REGISTRATION:

Prices will remain the same for 2009. There will still be a \$20 discount on the first day (no multi kid discount this day). There will be a multi-kid discount on all other dates (\$20 off the total registration fee).

Saturday May 30, 2009, 9 am to noon
Thursday June 4, 2009, 6 pm to 8 pm
Saturday June 6, 2009, 9 am to noon

Draft will be held Tuesday, June 23, 2009.

John will finalize these dates with Principle Kyle Brigance.

Any child registered after June 6th will be placed on a waiting list. Placement on a team is not guaranteed. A child will only be placed if there is an open spot on a team after draft or if another player drops. If a child is placed there will be a \$20 late registration fee.

Maximum team size was discussed and all agreed to the following:

| Age Group | Maximum Players |
|-----------|-----------------|
| 5-6 | 12 |
| 7-8 | 17 |
| 9-10 | 18 |
| 11-12 | 20 |

Everyone agreed it would be beneficial to add a third official to the 7-8 age group games.

A situation involving coach Frank McNeil was discussed. John will ask Frank to come to the next meeting with any evidence/persons needed to resolve the issue.
